# Speakers

Speakers for the **Labor and Employment Laws** workshop include three attorneys from respected Nebraska law offices who have represented both public and private sector employees in labor relations and employment matters and the Regional Director with the National Labor Relations Board.

**William A. Harding**, Harding & Shultz, P.C., LLO, Lincoln. Bill will be serving as our moderator. He has served as Chairman of the NCCI Labor Relations Council and a member of the Board of Directors since 1983. Bill has limited his practice to representation of management in labor and employment matters since 1969. He has been a Fellow in the College of Labor and Employment Lawyers since 1997. In 2007 and 2008, Mr. Harding was designated as one of the Top 100 Labor Attorneys in the United States by the Labor Relations Institute, Inc., from the more than 8,600 labor attorneys in the LRII database. He serves as General Counsel to several well-known Nebraska businesses and Labor and Employment Counsel for the Nebraska State Bar and League of Nebraska Municipalities.

**Daniel L. Hubbel** is the Regional Director with the National Labor Relations Board, Region 17, located in Kansas City. Region 17 administers the National Labor Relations Act, the basic law governing labor relations involving unions, employers and employees, throughout Nebraska, Kansas, Oklahoma, western Missouri and several counties in Iowa. Mr. Hubbel, during his extensive career with Region 17, has had the opportunity to investigate, process and determine the legitimacy of numerous unfair labor practice and representational cases throughout the Region.

**Scott S. Moore** is a partner of the Omaha, Nebraska law firm of Baird Holm, LLP, where he practices in the areas of management-side employment law and labor relations. He regularly represents employers in various industries with respect to labor relations and employment matters. He has represented employers on labor and employment matters

throughout the United States and was previously Vice President of Human Resources for a New York Stock Exchange organization.
