**RD** – Decertification election, employees vote on whether they no longer wish to be represented by a union.

**RM** – Representation election sought by an employer.

**UD** - Deauthorization election, employees vote on whether to eliminate a union-shop requirement.

**Stipulated election** – The parties agree to election terms and post-election decisions by the regional director may be appealed to the Board.

**Consent election** – The parties agree to election terms and all post-election decisions by the regional director are final.

**Directed election** – The Regional Director sets election terms and decisions may be appealed to the Board.
