¹ In the Stipulated Election Agreement, the parties did not agree on whether employees in the classifications of shift quality control and physical testers should be included in or excluded from the bargaining unit, and requested that individuals in these two classifications vote subject to challenge and that their eligibility or inclusion would be resolved following the election. After the close of the last poll, but before the commencement of the counting of ballots, the Petitioner and the Employer stipulated that individuals in the classifications of shift quality control and physical testers should be included in the bargaining unit and their ballots be opened, commingled and counted with the other ballots.
